



#### **Supporting Member States**

#### Via Steering Group on Promotion and Prevention (SGPP)

- Late 2018: mental health priority theme for good practices scale up
- Spring 2019: 11 practices showcased at 'market place'
- Summer 2019: ranking exercise for national relevance
- 3rd Health Programme 2020 work plan: calls to implement top three




## 3rd Health Programme 2020 Annual Work Plan: EU support up to EUR 7 (1.6 + 5.4) million

- European Alliance Against Depression (EAAD)-Best Project
  - Preventing depression
  - Implementing iFightDepression intervention in 8 countries
  - Started in April 2021


- ImpleMENTAL Joint Action :
  - Suicide prevention (Austrian)
     14 countries incl. FI, NO, ICE
  - Mental health system delivery (Belgium reform): 11 countries
  - Started in Oct 2021



#### Impact of COVID-19....




## Share of population experiencing anxiety, March-April 2020 compared to pre-COVID-19 (SOHEU, 2020)

# Further opportunities for best practice implementation via EU4Health

- First (2021) annual work plan EU4Health Programme
  - Call for proposals: action grants to support implementation of best practices on the ground with direct impact on the effort to tackle mental health challenges during COVID-19
  - EUR 750 000, deadline proposals 25 January 2021
- Exploring efforts for 2022, e.g. focusing on those disproportionately affected by pandemic (young people, vulnerable groups)
